Format

Documents required to be sent to the Registrar pursuant to the Act must conform to regulation 3 of the Regulations under the Act.

Items 1, 2

Set out the full legal name of the company and the number of the company as indicated in its Certificate of Incorporation.

Item 3

State the full address of registered office of the company.

Item 4

Indicate which section of the Act is applicable by ticking the appropriate box and state the date the declaration in question was received.

With respect to each person holding shares in the company, who does not hold the beneficial and/or controlling interest in the shares held, set out particulars as indicated below:

Item 5a)

- (a)i. In the case of a natural person state the first given name, middle name and family name of the person(s) who the change(s) applies to and set out the particulars of any change of name of the natural person including the new name, date of change and by virtue of what authority the change of name was effected;
 - ii. In the case of a body corporate state the registered name of the body corporate(s) which the change(s) applies to and set out the particulars of any change of name of the body corporate including the new name and date of change;
- (b) The address needs to be stated only if there is a change in the location or address:
